1. CHAIRMAN OF THE MEETING

Pursuant to Regulation 24(1) of the Insolvency and Bankruptcy Board of India (Insolvency Resolution Process for Corporate Persons) Regulations, 2016. Mr. Kondisetty Kumar Dushyantha, the Resolution Professional occupied the chair and initiated the roll call for the participants of the meeting.

2. QUORUM OF THE MEETING

Pursuant to Regulation 22(1) of the Insolvency and Bankruptcy Board of India (Insolvency Resolution Process of Corporate Persons) Regulations, 2016, the Resolution Professional confirmed the presence of requisite quorum.

The meeting being quorate, the Resolution Professional called the meeting to order.

3. NOTING THE MINUTES OF THE PREVIOUS COC MEETING HELD ON 16.05.2023.

The Chairman placed the minutes of the 29th Meeting of the Committee of Creditors held on 02.08.2023 that was circulated on 21.08.2023.

The Committee took note of the same.

4. NOTING THE STATUS OF CORPORATE INSOLVENCY RESOLUTION PROCESS OF SKYLARK MANSIONS PRIVATE LIMITED - PROJECT ITHACA

The Chairman informed the committee about the actions and events during the Process from 25.07.2023 to 31.10.2023 as follows:

1. Proceedings before the Appellate Authority:

The appeals listed before the Hon'ble NCLAT against insolvency commencement had come up for hearing on 14th September 2023 and the same has been adjourned to 28th November 2023.

2. Proceedings before the Adjudicating Authority:

The Hon'ble NCLT had listed the matters for hearing on all the pending applications on 12th September 2023 and at the hearing, the Hon'ble NCLT approved to exclude a further period of only 45 days as requested by the RP i.e., from 17th July 2023 to 1st September 2023 for the purpose of computing the time period for CIRP and allowed the application filed by the Homebuyer for condonation of delay vide 439/2023 and the pending applications were adjourned to 17th October 2023. Further at the hearing held on 17th October 2023, the following condonation applications filed by the Homebuyers were disposed of by the Hon'ble NCLT:

3. Opening of Bank Account:

In connection with RBI's need for discipline circular the undersigned in consultation with Committee of Creditors has opened a separate bank account in ICICI Bank at Koramangala 8th Block Branch for CIRP of Project Ithaca and to receive the contributions from the Homebuyers.

4. Reconciliation of CIRP Cost:

The RP has taken effort to reconcile the receipts from stakeholders towards CIRP cost and consolidate the same.

5. Website updates to all the Homebuyers:

Following disclosures have been made on the website for the information of the stakeholders:

- a. CIRP Cost allocation to Homebuyers.
- b. Details of Bank Account for remittance of CIRP Cost.
- c. Notice and Agenda for the 30th Meeting of CoC.

6. Removal of materials from the site of Project Ithaca:

At the hearing held on 17th October 2023 L&T submitted that they removed 70% of their material from the Project Site and sought further time for completion of the same from NCLT.

7. Status of Site cleaning activity:

The cleaning activity at Site - Project Ithaca is in process and the photographs depicting the same have been submitted to the Hon'ble NCLT vide progress report. Further, the said photographs were also displayed during the meeting.

The Committee took note of the same.

5. NOTING THE WAY FORWARD FOR EXECUTION AND COMPLETION OF THE PROJECT

The Chairman informed that implementation of MoU dated 13.12.2022 was delayed due to multiple applications filed for and against its implementation with the adjudicating authorities.

He further informed that the Members of SIBWA and Erstwhile Promoters informed the resolution professional about the informal proposals received from

Ramky Group, to carry out the construction activity and in this context a request was received from CoC Members to invite Ramky Group to discuss on the proposal and way forward and accordingly Ramky Group was invited to the CoC Meeting.

Further, the Chairman requested Mr. Saleem Sheriff, Promoter to explain the CoC about the proposal received from Ramky Group.

Mr. Saleem Sheriff informed the committee that they were scouting for developers and investors for the project and have identified Ramky Group for development and management of the project and are having active consultations in this context including SIBWA members as well.

Ramky Group was represented by Mr. Taraka Rajesh Dasari, Director and Mr. Kishore Nanda, CEO and Ms. Pujitha.

Mr. Kishore Nanda, the CEO of Ramky Group, informed the committee they had interactions with the homebuyers and finalized a way forward for commencement of construction. He further added that they were trying to understand the concerns of homebuyers and were contemplating steps necessary to consummate the transaction, including studying the feasibility of settling some creditors and takeover of the Project.

Mr. Raghuram Machi, the Authorized Representative, enquired if there has been any formal written communication of the offer by Ramky Group, the Resolution Professional confirmed to the committee that he was not in receipt of any such written offer.

Ms. Kalpana Mukherjee, representative of ICICI Bank, expressed that they shall be keen to consider any proposal for resolution as a Bank.

Mr. Mahesh Jagiasi, representative of SIBWA, enquired if Resolution Professional could initiate and take steps for construction of the project as the homebuyers were desperate for the same.

The Resolution Professional informed the committee that if the CoC considers and contributes the construction cost, he shall be obliged to facilitate the same pursuant to the provisions of the Insolvency and bankruptcy Code, 2016.

6. APPROVAL FOR THE CORPORATE INSOLVENCY RESOLUTION PROCESS COST INCURRED BY THE ERSTWHILE RESOLUTION PROFESSIONAL, MS. BHUVANESHWARI RAMANATHAN DURING HER TENURE

The Chairman informed the committee that the erstwhile Resolution Professional Ms. Bhuvaneshwari Ramanathan was in office as Interim Resolution Professional and Resolution Professional of Skylark Mansions Private Limited from 07.02.2020 i.e., the date of commencement of Corporate Insolvency Resolution Process till she was replaced by Hon'ble National Company Law Tribunal, Bengaluru Bench vide Order dt. 03.05.2023 in I.A 263 of 2023 in C.P in 389 BB 2019. He further informed that erstwhile Resolution Professional made an appearance before the Hon'ble NCLT and mentioned the non-payment of the said remuneration.

Thus, the Authorized Representative for Homebuyers pursuant to section 25(3A) of the I&B Code, having not received the simple majority of 51%, rejected the resolution.

Since the resolution did not receive the required majority, the same stands rejected by 84.93 % votes polled against it carried out vide e-voting on Right2Vote which was kept open from 12.00 p.m. of 06.11.2023 to 06.00 p.m. of 27.11.2023.

The Resolution Professional had agreed to take up the assignment for a professional fee of Rs. 3,50,000/- per month excluding GST and out of pocket expenses.
